Plan Review
Plans are required for all building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act #299 of the public Acts of 1980, as amended, and shall bear that architect's or engineers signature and seal, except: when electrical system does not exceed 400 amps and the building is not over 3,500 sq feet. Plans must be submitted before permit is issued. If work is started before permit is applied for, an additional fee will be charged. Required Not-Required

No work shall be concealed until inspected. If an inspection is requested but cannot be completed due to inaccessible job site a re-inspection fee will be charged. A permit will be cancelled when no inspections are requested & conducted within six months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.

Homeowners Affidavit: I hereby certify that the electrical work described on this permit application shall be installed by myself in my own single family dwelling in which I am living or about to occupy. All work shall be installed in accordance with Michigan electrical code and shall not be enclosed, covered up, or put into operation until it has been inspected and approved by the Electrical Inspector.
